

MCSW Tournament Rules

All adult tournaments, managed by the Metro Phoenix USBC association, are open to all currently certified bowlers, within the state of Arizona, and those certified in Blythe, California.

1. ALL PARTICIPANTS MUST BE FEMALE MEMBERS AND HAVE A CURRENT USBC ADULT MEMBERSHIP CARD IN ANY ASSOCIATION WITHIN ARIZONA OR BLYTHE, CALIFORNIA, AND BE 50 YEARS OF AGE AS OF THE TOURNAMENT OPEING DATE. NO TRANSFER FEES REQUIRED.
2. Qualifying average in order of acceptability shall be:
 - a. 2009-2010 highest book average of 21 or more games.
 - b. Highest 2009-2010 league average for 21 or more games from summer or winter with written verification from the league secretary.
 - c. 2010-2011 winter average for 15 or more games.
 - d. If none of the above, bowler will be assigned an average of 200.
 - e. Ref. USBC Rule 319(a)3; It shall be the bowler's responsibility to verify accuracy of her average. USBC Rule 319(a)2, 319(b), 319(d) and 319(e) will not apply. USBC Rule 319(c) will apply.
3. Bowlers may enter each event only ONCE. Bowler may enter Doubles, Singles or both.
4. Tournament participants are not allowed to practice within two hours of squad time on their scheduled lanes.
5. Prize fees will be returned 100% with a minimum ratio of 1 to 8 in each event (with the exception of the Scratch and/or Handicap All Events which will be a minimum of 1 to 16 in either event.)
6. Championship awards will be awarded in each division, based on actual (scratch) scores for Doubles and Singles. Prize money will be distributed for the field on a handicap basis. Handicap to be 90% of 230
7. All Events monies will be paid to the winner only if she has paid the optional prize fee of \$2.00. The Over-All Winner of All Events (based on handicap), will be awarded a paid entry to Doubles, Singles and All Events in the 26th Annual Maricopa Senior Women's Bowling Tournament. In the event of a tie, Co-Winners will be declared and duplicate entries will be awarded.
8. All events entries may be transferred provided such transfer is made before the bowlers involved have participated in any event of the tournament.
9. Team captains and Doubles & Singles entrants shall register 30 minutes prior to their scheduled squad starting time. Late bowlers may bowl in accordance with USBC Rule 322. All participants will be at their scheduled squad time or be subject to forfeiture of their entry. There will be no lineup changes in any event.
10. Replacements made in any event must be in accordance with USBC Rule 324(b).
11. Substitutions made at the tournament site must complete the entire series in which they substituted. Examples: Team For Team, Doubles for Doubles, and Singles for Singles.
12. No entry fees will be returned after the tournament has begun. (USBC Rule 314)
13. No unreasonable delay in the progress of any game will be permitted. (USBC Rule 11)
14. All decisions of the tournament committee will be final, unless an appeal is filed with tournament management.(USBC Rule 329)
15. In an effort to keep the squads on time one-lane courtesy is requested.
16. Reserved entry deadline is October 19, 2010. If space permits entries will be accepted up to October 22, 2010.

Tournament/Association management reserves the right to cancel any tournament and/or squad, due to lack of entries/participation, by the closing date of the tournament, or as deemed necessary. All entries with fees will be returned to the team captains.

The current USBC Book of Rules shall govern any rule not covered above.

DRESS CODE: The USBC National Tournaments (Open and Women) dress code will apply. Slacks, jeans, hemmed shorts, skorts, skirts of at least mid-length and pants covering at least to mid-calf are allowed. T-shirts, tank tops, workout attire (sweatpants spandex), halter tops, bare midriff/tube tops and spaghetti tops are not allowed. All shirts/blouses will have collars, with the exception of "mock" collared shirts being allowed. Hats, caps, clothing with obscenities, holes, frays, tears, etc. are not permitted. **No electronic equipment of any kind is allowed during competition. This includes but is not limited to, cell phones, pagers, video recorders, palm pilots, Ipods, etc.** The tournament Director will have the final decision regarding acceptable attire.
